<b>6. Description of content:</b> Proposal for the additional designation of 3 substances as <i>Shitei Yakubutsu</i> , and their proper uses under the Act.
<b>7. Objective and rationale, including the nature of urgent problems where applicable:</b> In order to prevent the abuse of substances with probable effects on the central nervous system and to clarify the regulation under the Act, the MHLW designates such substances as <i>Shitei Yakubutsu</i> . Manufacture, import, sale, simple ownership and the use of <i>Shitei Yakubutsu</i> are banned except for the proper uses designated under the Act.
